The Interactive Process—What is it?

Many employers have been told that they need to conduct the Interactive Process as part of the effort to accommodate workers who are disabled. But many have questions about the process and how to conduct it, as well as what constitutes a reasonable accommodation. Here are a few things to keep in mind about the Interactive Process:

- FEHA (Fair Employment and Housing Act) dictates the Interactive Process should be provided in a *timely manner*
- The Interactive Process should be engaged in with an employee who is disabled or who the employer *perceives to be disabled*
- Involving rehabilitation specialists or medical personnel in the Interactive Process has been deemed appropriate by California's courts
- Suitable accommodations include, but are not limited to, the following:
 - Part-time work
 - Job modification
 - Job restructuring
 - Policy restructuring
 - Obtaining ergonomic equipment or assistive devices
 - Making facilities more accessible

With all of the specifics regarding the Interactive Process, you may consider consulting with a Disability Management Specialist. Since disability discrimination lawsuits are the largest segment of discrimination lawsuits in the State of California, this may be a wise decision, to keep your employer out of trouble!
